TERMS & CONDITIONS

HOW TO MAKE A BOOKING:

All bookings should be made by filling this form and submitting it via email to bookings@thecommonskhi.com Please ensure all information is provided and your booking is correct and complete otherwise it will not be accepted.

PAYMENTS:

TCK is a prepaid market; therefore, all payments must be cleared in full for your booking to be confirmed prior to the market date. Once the booking is confirmed via email, the vendor is liable to pay the full amount via bank transfer or credit/debit card on our website.

CANCELLATIONS AND REFUNDS:

All cancellations must be made in writing to bookings@thecommonskarachi.com TCK will not accept any verbal cancellations at a market, WhatsApp or over the phone.

Cancellations and date changes can only be made 15 days prior to the market date, and a credit note will be issued to the vendor's TCK Account.

TCK will not offer cash refunds at any time.

Cancellations will be awarded in credit notes only and can only be used at another TCK Event.

FORCE MAJEURE:

TCK will take place come rain or shine and shall not be liable for any cancellations, delays or failures in performance due to circumstances beyond its control.

In case of cancellation of the event or unavailability of the event space for specified use due to war, governmental action or order, act of God including, but not limited to, weather, fire, strike, labor disputes, or any other cause beyond the organisation's control, this agreement shall terminate, and the vendor shall be entitled to the return of the rental space fee for the event space less an amount equal to the total costs and expenses incurred by the market in connection with the preparation of vendor's event space.

SAFETY & WASTE MANAGEMENT:

All TCK vendors must ensure that you do not leave your discarded packaging or rubbish at the venue. NO liquids including water/ oil/ ice to be discarded at the venue.

BRANDING:

No standees are allowed. No branding of any kind can be placed on any venue property aside from the designated space. Branding without approval by the TCK team will be removed.

MARKETING:

It is in the interest of every TCK Vendor that if they want their business to succeed at the TCK market, they must inform their existing customers and follower base about their participation at all events via social media platforms, company website and any other network channels to create awareness.

TCK will seasonally create a fully integrated marketing campaign for our events. Our social media channels are an integral part of this campaign. Features and vendors are chosen at the discretion of our marketing purpose.

DISCLAIMER:

The Commons Karachi is not liable or responsible for any of the following circumstances:

- The TCK Vendor is, and Organizer shall not be, responsible for the damage or loss of any of the TCK vendor's items.
- The Organizer is not liable for any losses, damages or injury to the TCK Vendor or its employees, consultants, contractors, visitors, or customers during the partnership period or after extended.
- The Organizer shall have security presence for the venue however the TCK Vendor is responsible for securing their area.
- The Kiosks are the property of the Organizer and upon the termination of this agreement will remain the property of the Organizer.
- At the end of the Market, the TCK vendor must remove all items off the events. Should the TCK Vendor not remove their items, the Vendor agrees and permits the Organizer to remove and dispose of these items on their behalf and charge any costs. The TCK Market Vendor must follow merchandising feedback from The Organizer and ensure they are acting in the best interests of The Organizer and The Event. The Vendor is responsible for keeping their area restocked, well presented, and merchandised - at all times.
- The TCK Vendor must act in the best interest of the First Party at all times, if this is not being adhered to The Organizer has the right to remove The Vendors products and terminate the agreement without refund or compensation until the situation is resolved.
- Offending any visitors at one of our events, due to inappropriate behaviour or dress code.
- For any members of employees, or third-party consultants representing member companies for any food products sold at the TCK Market that may cause sickness or injuries.
- TCK can use Vendor participants full names, photos, or other types of representation of the events without asking permission of the subjects.
- By registering as a TCK Vendor, you consent to your details being added to the our database and receiving information via newsletter or direct messages on vendor promotions and TCK Market news.

- **Any TCK Vendor that is not acting in the best interest of the event, TCK has the authority to ask the vendor to leave without refunding the participant's amount. Any vendor who damages or destroys any TCK Market Property will be charged and held liable for covering all costs to rectify the damage.**
- **No outside food or beverage can be brought into or consumed at the Market. All food and beverages must be purchased from one of the participating TCK Market Vendors.**
- **No third-party advertising can be made during the TCK Market events. Anyone found to be doing this will be asked to leave.**
- **All Market Vendors must adhere to TCK's third-party sponsorship requirements when announced.**
- **The TCK Market Vendor is responsible for all direct and indirect costs associated with the setup and operating of their space and follow all rules and regulations of the organizer and venue.**
- **By entering the markets, you consent to being recorded by photography, audio and video and its release, publication, exhibition, or reproduction.**
- **By signing up for a market, you agree to participate for the full duration of the TCK market timing and agree that the TCK Market has the right to refuse future participation due to this.**
